NOTIFICATION

No.F.13/11/2018/HP-I/Estt./_____. In exercise of the power conferred by sub-section (1) and (2) of section 147 of the Delhi Police Act, 1978 (34 of 1978), the Lt. Governor of the National Capital Territory of Delhi is pleased to make the following amendments in Rule 14(a) of Delhi Police (Appointment and Recruitment) Rules 1980 and Delhi Police(Appointment & Recruitment) Rules, 2013 regulating the method of recruitment to the Group "C"-Women Sub-Inspector(Executive), namely:-

Short title and commencement

- (1) This Rule may be called the Delhi Police (Appointment & Recruitment) (Amendment) Rules, 2018 for the post of Women Sub-Inspector(Executive).
 - (2) This shall come into force with effect from the date of publication in the Delhi Gazette.
2. **Number of posts, classification, pay band and grade pay or pay scale:-** The number of posts, their classification and scale of pay attached thereto shall be specified in columns (2) to (4) of the Schedule Annexed to these rules.
 3. **Method of recruitment, age limit and other qualification etc:-** The method of recruitment to the said post, age limit, qualification and other matter relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
 4. **Disqualifications/Ineligibility:-** (i) No person who is not a citizen of India shall except with the consent of the Central Government to be obtained in writing in advance, be appointed, enrolled or employed in Delhi Police.
 - (ii) Every candidate shall make a declaration in form No. B about her marital status before she is enlisted.

- (iii) No person shall be appointed to any post in Delhi Police unless she has been certified on as physically fit for Police service by form D & F by a medical authority to be appointed for the purpose.
5. **Power to relax:-** Where the Government is of the opinion that it is necessary expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of this rule with respect of any class or category of persons.
6. **Saving:-** Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, Other Backward Classes, Widows/Divorced women/Women Judicially separated or any other special category of persons in accordance with the orders issued by the Government from time to time in this regard.

(6) Age limit for direct recruits	Between 20 to 25 years. Relaxable upto :- (i) 28 years for OBCs and 30 years for SCs/STs candidates. (ii) Upto 35 years (38 years for OBCs and 40 years for SCs/STs) for widows/ divorced women/women judicially separated and who are not remarried (iii) Upto 30 years (33 years for OBCs and 35 years for SCs/STs) for departmental candidates of Delhi Police with minimum of 3 years of continuous service.

<p>(7) Education and other qualification required for direct recruits</p>	<p>(A) Essential Educational Qualification:- Bachelor's degree from a recognised University.</p> <p>(B) Essential Physical & Medical Standards</p> <p>(a) Height: Minimum 157 cms, relaxable by:-</p> <p>(i) 3 cms (154 cms) for ST candidates.</p> <p>(ii) 2 cms (155 cms) for candidates belonging to Hill areas.</p> <p>(iii) 5 cms (152 cms) for compassionate appointments.</p> <p>Note:- :- "The relaxation in physical standards (height) once granted at the time of initial appointment in Delhi Police will hold good till the individual concerned remains in Delhi Police".</p> <p>(b) Weight: Corresponding to height.</p> <p>(c) Medical Standard:</p> <p>(i) The minimum distant vision should be 6/6 and 6/9 of both eyes without any correction like wearing glasses or surgery of any kind to improve visual acuity.</p> <p>(ii) The candidate must not have knock knee, flat foot, varicose vein or squint in eyes and they should possess high colour vision.</p> <p>(iii) They must be in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of the duties.</p> <p>(iv) Tattoos on various parts of body:-</p> <p>(a) Content - Tattoos depicting religious symbol or figure and the name, as followed in Indian Army, shall be permitted.</p> <p>(b) Location – Tattoos marked on traditional sites of the body like inner aspect of forearm, but only left forearm, being non saluting limb or dorsum of the hands shall be allowed.</p> <p>(c) Size – Size must be less than ¼ of the particular part (Elbow or Hand) of the body.</p>
<p>(8) Whether age and educations qualifications prescribed for direct recruits will apply in the case of promottee</p>	<p>Not applicable</p>
<p>(9) Period of probation, if any</p>	<p>Two (2) years.</p>

(10) Method of recruitment, whether by direct recruitment or by promotion or by deputation/transfer & percentage of the vacancies to be filled by various methods	50% of vacancies shall be filled by direct recruitment and 50% by promotion.
