

Update on News reports relating to crime.

Reference- News item captioned "Badmashon Ke Tandav Se Yamunapaar Main Khof" appeared in the Amar Ujala dated 5.4.2010

The report on the incidents pertaining to North-East Distt. is as under :-

1. On 1.4.2010, two incidents happened in the area of Seemapuri robbery at the point of knife. In both incidents, no body got injured. In this regard, two cases were registered vide FIR No 101/10 u/s 382/34 IPC and 102/10 u/s 382/34 IPC respectively. In both cases, accused have been arrested. Both the cases are pending investigation.
2. On 29.3.2010, a quarrel took place on account of payment of money between Dharam Singh and Manjeet Singh at Panchsheel Garden, Shahdara. Manjeet Singh with his four nephews assaulted Dharam Singh with sword and ran away. A case vide FIR No. 177/10 u/s 323/324/34 IPC and u/s 27/54/59 Arma Act was registered against Manjeet Singh and his four nephews. All the accused have been arrested.
3. Regarding the incident which took place at Yamuna Vihar on 1.4.2010. A case vide FIR No. 153/10 dated 1.4.2010 u/s 304 IPC PS Bhajanpura was registered and four persons including three police personnel were arrested. Now, the case is being investigated by DIU/NE Distt.
4. Regarding the incident of murder at Yamuna Vihar a case FIR No 154/10 u/s 302 IPC PS Bhajanpura was registered and three

persons have
been arrested in this case.

5. On 29.3 2010, one person was allegedly murdered by strangulation in the area of PS New Usman Pur. Initially, on receipt of the above information, a case FIR No. 109/10 u/s 302 IPC was registered. During the course of investigation, the body was identified as Ram Kumar. On receipt of PM report, Dr. opined no strangulation is found and deceased had died a natural death. Hence, the above case is being cancelled.

The report on the incidents pertaining to East Distt. is as under:-

1. One girl namely Soni aged 7 years was lodged at Vatsalya Mandir a home for minor children by local police of PS Shakarpur from where she was found missing on 26.3.2010. A case FIR No. 58/2010 u/s 363 IPC was got registered on 30.3.2010. Later on, Soni was found by her mother weeping in the train and she took her daughter to home . No foul play was found in the missing of the girl. The case was cancelled.

2. In connection with one incident of robbery which occurred on 1.4.2010 in the area of Shakarpur, a case vide FIR No.248/2010 u/s 394/34 IPC was registered at PS Shakarpur which is pending investigation.

3. The incident of snatching of gold chain from a lady in the area of Farsh Bazar, published in News paper was not reported to PCR or local police of PS Farsh Bazar, hence, due to non reporting of incident, no case has been lodged by police.

All ACsP/SHOs/North-East & East Districts have been briefed and sensitized about the contents of the news clipping and they have been directed to increase patrolling and picket duties as well as to keep close watch over the activities of BC's, Ruffians and other known criminals to prevent such incidents in their respective areas.
