**APPRECIATION OF PROMPT ACTION BY DELHI  
POLICE IN APPREHENDING CULPRITS**

Dear Sir,

1. I take this opportunity to bring to your notice the exemplary work done by No – D-1875 SHO Rishi Pal Rana, SHO, Rani Bagh Police Station, Delhi and his team of policemen in combating crime against woman and children in the subsequent Paragraphs.

2. On 17 Aug 2015, my wife was returning from Bal Bharati Public School Pitampura in her car along with our children. Due to road congestion, her car halted/slowed down. Two young men who were travelling in a following Santro car started honking continuously to get the traffic moving. Once the road broadened, my wife moved her car to the left of the road to, let the impatient driver overtake my wife's vehicle. The young men in the (following) Santro car brought their car astride and started abusing. Thereafter, they overtook and halted their car right in front of my wife's vehicle thus blocking her way and prevented her from moving ahead. Both these young men came out of their car and used unparliamentary language and gestures against my wife and children. They soon returned to their car but deliberately obstructed our vehicle, every time my wife tried to move ahead. They obstructed the way thrice. My children noted down the offending Santro car's registration number and dialled 100 telephone number for police assistance. They were advised to contact the area Police Station.

### **Prompt Police Action.**

4. The following exemplary, prompt response by SHO of Rani Bagh Police Station, Delhi and his staff merits highlighting the professional alacrity with which the criminals were caught by these policemen : -

(a) The moment the ibid SHO of Rani Bagh Police Station, Delhi, learnt about the complaint; in less than a minute he obtained the ownership details of the Santro car that was used by the culprits.

(b) The SHO of Rani Bagh Police Station, promptly ordered Head Constable Rajesh Rana of his Police Station to produce the culprits as, they were from the local area. Head Constable Rana in less than 20 minutes produced the young men at the Police Station.

(c) Once the culprits arrived, arrogance and smugness was evident on their faces. However, a little conversation between Assistant Sub Inspector Ramesh Kumar, Woman Assistance Sub Inspector Mrs Nirmal and Head Constable Rajesh Rana made the culprits aware of the seriousness of their offence and they confessed to their crime.

5. This quick action by the Policemen of Rani Bagh Police Station will instil a sense of deterrence amongst these young men and make them think twice before committing a crime again. The excellent professionalism observed by me in respect of each these Police personnel is enumerated in the subsequent Paragraphs.

6. **SHO Rishi Pal Rana.** The action by the SHO shows that he possessed a sound professional acumen regarding combating crime and has a good command over his men and women. He was clear right from the beginning how as to, how to solve this complaint effectively. He was sensitive to gender/women and child related crimes. The SHO manifest good leadership skills, sound soft skills and a very high degree of professionalism, which included the use of technology and field work.

7. **Head Constable Rajesh Rana.** The ability of Head Constable to produce the culprits in less than 20 minutes at the Police Station is extremely commendable. It speaks volumes of his professional and policing skills as to, how to locate and apprehend criminals quickly and get them to the poice station with least resistance.

8. **Woman Assistant Sub Inspector (WASI) Mrs Nirmala.** The supportive role of Woman Assistant Sub Inspector (WASI) Mrs Nirmala is also laudable. She was present during the interaction and helped shame the young men for their misdeed.

9. The role of all these Policemen goes to show a high degree of camaraderie amongst 'this' police team, their commitment to combating crime and the high degree of professionalism ingrained in them for making Delhi a safe place for all. Their efforts upheld the Delhi Police Moto "Shanti Sewa Nyaya".
